- Remain respectful, professional, and listen to everyone.
- Given the number of objectors who have requested speaking time, speakers' initial times for presenting their proposed resolutions are limited to 5 minutes. This time limit will allow for additional discussion and follow-up from the reviewing official as needed. "Go-backs" will be allowed as time permits and after all scheduled objectors have spoken.
- Failure to adhere to these ground rules may result in your allotted speaking time being cut short.
