


THE FIGHT OVER MABEE ROAD

When the gate on the Mabee road in Fergus County was locked back in 2007, PLWA was there to take action. The Mabee Road is a major public access route into the remote Upper Missouri River Breaks. There is a well-documented history of long-standing public use of the Mabee Road dating back to the early 1900's.

PLWA's case for public access to the Mabee Road culminated in a September 2018 trial. Using the testimony of local folks with decades of hunting and other recreational experience in the Upper Missouri River Breaks, PLWA defended the public's rights and stood up against the wrongful attempt to block access to this expansive prime elk habitat and hunting area.

We now await the Court's decision. While we don't know exactly when the ruling will come out, we will let everyone know the result of the trial as soon as we do!
